Skips are for general and inert waste such as soil, garden waste, paper, plastics, wood, old furniture etc. Any waste on the list below cannot be placed in a general waste skip.

### Terms and Conditions

#### 1 General

**1.1** Any order placed with G D Golding Skip Hire Ltd. which takes its vehicles off the public highway will be at the customers own risk, they will accept full responsibility for any consequential damage that may occur to persons or vehicles because of this. It is the customers responsibility to ensure the location is suitable and adequate to bear the weight of a Skip lorry loaded or unloaded. This includes drain covers, drive edging bricks, paving slabs (these items should be covered by the end customer before delivery/exchange/collection as Goldings will not take responsibility for the damage of these at the location). This also applies to any damage to property such as drain covers, walls, fencing and hedges at the request of the customer wishing to place the skip over or past these.

**1.2** G D Golding Skip Hire Ltd. will not be liable for any loss or damage caused by failure to supply, or any delay in supply which may be caused directly or indirectly by any circumstances beyond our control, including act of God, fire, accident, breakdown of machinery, shortage of labour or material, or by an act of neglect on the part of the customer.

**1.3** The time allowed for loading/unloading is 15 minutes. If the vehicle is kept waiting longer than this G D Golding Skip Hire Ltd. reserves the right to charge waiting time at a rate of £15 + vat per 15 mins thereafter.

**1.4** G D Golding Skip Hire Ltd. reserves the right to charge the customer for all costs incurred as a result of a cancellation, change of waste type or variation of the whole or a substantial part of an order, together with loss of profit and all other consequential loss, wasted journey, access issues, change of skip size. **Wasted journey charges will start from £105 + vat**

#### 2 Skip Hire

**2.1** Asbestos, fridges, freezers, televisions/monitors, tyres, fluorescent/sodium lamps, gas cylinders, plasterboard, or any waste deemed as hazardous by an absolute or mirror entry in the European Waste Catalogue (Article 1(4) of the Hazardous Waste Directive 91/689/EC) must not be placed in the skip container unless by prior written agreement with the company.

**2.2** It is the responsibility of the hirer to ensure that skips placed on the highway or public places have the permission of the local highway authority and are adequately lit and coned off in accordance with the Highways Act 1980. G D Golding Skip Hire Ltd. can organise permits at an additional cost to the hirer, however, that payment is non-refundable once the permit process has begun.

**2.3** The hirer shall ensure that the skip is not overloaded by weight or by volume at the point of collection. Skips should be loaded so that they are filled no higher than the top of the sides. 12yd, 14yd, 16yd, 20yd up to 40yd roll on-off are only to be used for light waste or loaded no more than the maximum legal road limit for the vehicles. Excess waste may be removed and placed within the vicinity of the skip. **G D Golding Skip Hire Ltd reserves the right to refuse to collect overloaded skips and any costs incurred due to unsafe loads/overloading will always be passed on to the hirer.** Additional charges may be levied.

**OVERLOADING WILL ALWAYS INCUR EXCESS CHARGES STARTING FROM £50 + VAT**

**2.4** The lighting of fires in or near skips is strictly prohibited. The hirer will be liable for any loss or damage to the skip container (excluding fair wear and tear) during the term of the skip hire period, and will be charged the current purchase price for the skip. Once a skip has been placed, it shall not be repositioned without prior consent from G D Golding Skip Hire Ltd. Moving skips on site could result in inability to collect skip.

**2.5** The maximum rental period is 7 days for non-account customers and 28 days for Account customers. It is the responsibility of the hirer to ensure that the collection date pre-booked in is suitable and to advise the company at least 24 hours' notice should the date need to be amended. Collections can take anything up to 5 working days. If the rental period is exceeded a daily rental charge will be applied at-

**A rate of £25.00 + vat per day for 2, 4, 6, 8, 12, 14 & 16yrd skips.**

**A rate of £50.00 + vat per day will incur for 20 & 40 yard roll on/off's.**

**2.6** The responsibility for the skip and its contents remains with the hirer until collected by a G D Golding Skip Hire Ltd. vehicle. skips which are removed or stolen whilst in the control of the hirer will be charged at full replacement value.

#### 3 Tipping/Waste Disposal

**3.1** G D Golding Skip Hire Ltd. are registered with the Environment Agency as a waste carrier, further all landfill disposal sites are correctly licensed or approved.

**3.2** Customers using G D Golding Skip Hire Ltd. disposal sites do so entirely at their own risk. G D Golding Skip Hire Ltd. accepts no responsibility for damage or injury of any nature that may occur to persons or vehicles using these sites.

**3.3** Vehicles may only use such portions of the sites as are allocated to them.

**3.4** Only waste permitted under the waste permit licences or exemptions may be deposited on the sites.

**3.5** G D Golding Skip Hire Ltd. reserves the right to refuse any materials which it considers to be objectionable or unsuitable for deposit on the company's sites.

**3.6** Material for deposit on our sites will only be accepted from registered waste carriers, and must be accompanied by a controlled waste transfer note stating a description of the waste (with EWC code), the source of the waste and the details of the waste carrier, including carrier registration number. Environmental Protection (Duty of Care) Regulations 1991.

#### 4 Sale of Materials

**4.1** All materials are sold on the basis that the weight or quantity is as stated on the conveyance note. G D Golding Skip Hire Ltd. will not accept any responsibility once the load has been discharged and accepted by the onsite signatory.

**4.2** Unless expressly agreed in writing G D Golding Skip Hire Ltd. prices are for materials as stated on the quotation. Where the customer requires an alteration in the grade or type of material, or where it becomes necessary to supply from another source, an extra charge may be made for any additional costs which may be incurred by G D Golding Skip Hire Ltd

**4.3** Risk in the goods shall pass to the customer on delivery.

**4.4** All goods remain the property of G D Golding Skip Hire Ltd. until paid in full.

#### 5 Payment Terms

**5.1** Account holders: 30 days from date of invoice, or end of the month following delivery (subject to written agreement).

**5.2** Non Account holders: Prior to or on delivery of skip. The owner accepts major credit and debit cards, cash and bankers drafts.
